Scheme for Grant-in-Aid for Promotion of Naturopathy and Yoga

I. OBJECTIVES.

The main objectives of the scheme are to create and increase awareness among the community about the preventive, promotive and curative aspects of Naturopathy , its cost effectiveness, easy adaptability and benefits for prevention and treatment of common ailments. The scheme is intended to create an interest particularly in looking after basic primary health care needs and attain health self-sufficiency through Naturopathy and Yoga.

II. ELIGIBILITY

One day Naturopathy Awareness Programme sponsored by NIN will be given only to Registered Licensed/ Naturopathy Organisations/ Institutions.

III. PROGRAMMES

- 1) 1-day Naturopathy and Yoga Health Education Programme for General Public.
Financial Assistance: @Rs. 7,000/- per programme.
- 2) 1-day Naturopathy and Yoga Awareness Programme for Women
Financial Assistance: @Rs. 7,000/- per programme.
- 3) 1-day Naturopathy Training Workshop for practitioners of any system of medicine:
Financial Assistance: @Rs. 10,000/- per programme.
This is given only to well established Naturopathy Hospitals. Minimum 25 Registered Medical Practitioners must attend this programme.
- 4) 5-days Naturopathy Training programme for Students
Financial Assistance: @Rs. 7000/- per programme.

The implementing agency may conduct 2 hour class per day for 5 days in any school / college. There should be at least 40-50 participants in each class. Daily attendance attested with the seal and signature of the Principal / Headmaster of the School / College must be forwarded to NIN with the completion report.

IV. STEPS TO CONDUCT THE PROGRAMME

1. Each Naturopathy Organisation/Hospital will be given only 4 programmes in one financial year, @ one in a quarter, which has to be completed between 1st April and 31st January. No camps will be normally given in the month of February and March.
2. Any Naturopathy Organisation/ Institute applying for Grant-in-aid, for the 1st time here in after , may remit Rs. 250/- by D.D. on any nationalized Bank at Pune, in favour of 'The Director, National Institute of Naturopathy, Pune'.
3. Submit following details with the application while applying for the first time only.
 - a. *3 years Annual Report*
 - b. *3 years Audited Accounts*
 - c. *Copy of the Registration / Licence Certificate*
4. Second time onwards only duly filled up application with details of Resource persons will be sufficient.
5. Proposal for each programme should be submitted separate.
6. Every application should reach Director, NIN, Pune at least one month in advance of the proposed date. Specify the exact dates of the programme in every proposal.
7. On receipt of the application, NIN will scrutinize the same and those which are in order will be given an approval letter. On receipt of the approval letter, the Institute can conduct the programme and send the completion report.
8. Two Resource persons must be engaged to conduct a One-day programme as minimum 2 classes on Naturopathy, Yoga classes and consultation are compulsory

V. The Completion Report should contain:

- i. Filled up completion format given by NIN.
- ii. Recommendation duly signed by the specified person in the given format.
- iii. Expenditure statement of the programme audited by Chartered Accountant.

- iv. **Audit Certificate (Utilization Certificate) in the given format.**
- v. **Photographs of all events in Original pasted on white paper with the description note below, describing the event, names of the Resource Persons or VIP's seen in the photo is compulsory. Xerox copies are not acceptable. One photo must be taken from the back side of the audience/yoga Class giving full view of the participants with faculty, stage, and banner together. Close up photos with faculties and dated banner is also compulsory. The Banner should contain "Sponsored by NIN – Pune" invariably.**

All Resource Persons whose names are given in the proposal must be seen in the photos. This will be cross checked. Number of participants in the given list must be actually seen in the photo which will also be cross checked. In the absence of any of the above the grant will not be given even though the programme is conducted.

- vi. **Copy of the paid vouchers towards remuneration to the resource persons duly signed by them.**
- vii. **List of Participants with their address and signature.**
- viii. **In case of students programmes, 5 days separate attendance duly attested by the Principal / Headmaster with signature and seal.**
- ix. **Completion Report should be send within one month from the date of completion of the programme. Reports received late will not be accepted.**

Recommendation to be procured and sent with the Completion Report.

Along with the completion report a certificate is to be procured from the District Co-ordinator of Nehru Yuvak Kendra Sanghatan or Local Panchayat Member / President / Secretary or a Govt. Naturopathy Medical Officer of your State or DMO / CMO of State AYUSH Department or any Gazetted Officer, is required to be sent without fail.

N.B. :

- 1. Rs. 400/- (Rs. Four Hundred only) will be deducted from the payment of each programme towards the subscription for NIN's magazine 'Nisargopachar Varta' for 2 years. If you are already a subscriber, you may use the additional copies for your institution library or may issue free to your patients or near and dear or you may suggest any address while sending the application or completion report so that we shall mail it directly to the party proposed by you.**
- 2. It is noticed that some are taking approval for General Public / Women programme and conducting programmes for students, which is not admissible. In such cases no grant will be allowed.**
- 3. The grant is provided to meet the expenditure on banner, pamphlets, newspaper advertisements, local TV channel, radio advertisements, honorarium, herbal tea, juices, course material if any and Naturopathic food if desirable.**

4. **NIN sponsored programme should not be mixed up with any other programme financed by CCRYN / AYUSH, etc on the same day.**

Strict Warning Against Misuse of NIN's Name.

It is observed that on approval of camps or other programmes sponsored by NIN some Are misusing the name of N I N by Publishing that they are "Recognized, Affiliated or Registered" with "NIN, Pune, Dept. of AYUSH, Ministry of Health & Family Welfare, Govt Of India ". This is unethical and against the "Improper use of emblems and Names Act. 1950."

Therefore it is strictly instructed that any NGO, conducting sponsored programme of NIN shall use the name of NIN only as given below.

"Sponsored by NIN" and Not to Use additions up to Govt. of India etc. as mentioned above.
